## DIRECT DEPOSIT

Get your refund faster --  
Tell IRS to Direct Deposit  
Your Refund to One, Two  
or Three Accounts

You have several options for  
receiving your 2008 federal in-  
come tax refund. You can:

- ◆ Split your refund with direct deposits into two or three checking or savings accounts
- ◆ Direct deposit your refund into one checking or savings account
- ◆ Receive your refund as a paper check in the mail, although this option takes a little longer

Whether you file electronically or on paper, direct deposit gives you access to your refund at least one week faster than a paper check. Direct deposit also avoids the possibility that your check could be lost or stolen or returned to IRS as undeliverable.

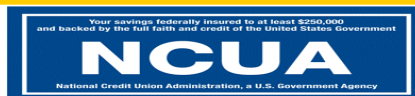

The NCUA has adopted New Bylaws for Federal Credit Unions to incorporate.

At the annual meeting an election\* will be held for 3 board positions. The nominating committee has submitted its nominations with a statement of qualifications and biographical data. Additional nominations may be made by petition, signed by a minimum of 20 members. Interested members can pick up a "District 05 DOTD Federal Credit Union Board Nominee by Petition" form from the Credit Union Office. Return the completed form along with the 20 signatures to the Credit Union Office so it can be filed with the Secretary of the Board **by February 27th 2009**. All nominations will be posted in the Credit Union Office following the deadline.
